**DATE:** Sunday June 14

**TIME:** 8:00 A.M. Sign-In                      9:00 A.M. Firing Commences

**LOCATION:** Cheyenne Rifle & Pistol Club Outdoor Range – 10 miles northwest of Cheyenne, WY. Go north on Interstate 25 to Exit 16, Horse Creek Road. West on Horse Creek Road for 3.3 miles to Telephone Road. North on Telephone Road For 2 miles. Turn East on dirt road for ½ mile to range gate. The match will be shot at the High-Power range.

**RIFLE:** Any version M1 Garand

**AMMO:** Any Safe Ammo. **NO** tracer or incendiary. 30-06 issued to club members.

**OPEN BOLT FLAG:** OBI/ECI required. Available for \$1.00 or may borrow one from the club. ECI must be inserted at all times except during the 3-minute prep and the timed match. ECI must be inserted at the conclusion of record fire.

**ELIGIBILITY:** Open to anyone 16 years of age and older. (15 and younger must be approved by match director)

**COURSE OF FIRE:** All matches will be fired from 200 yards and shot on SR targets. 5 Mins for unlimited sighter shots.

**Match 1** – Standing/Slow Fire - 10 Shots - 10 Mins

**Match 2** – Sitting/Kneeling/Rapid Fire - 10 Shots - 60 Secs

**Match 3** – Prone/Rapid Fire - 10 Shots - 70 Secs

**Match 4** – Prone/Slow Fire - 20 Shots - 20 Mins

**ENTRY FEE:** \$20.00/\$5.00 Returned for awards

**GENERAL INFORMATION:** The Shotmarker Electronic Targets System will be used. Competitors should bring an electronic device with sufficient power for a full day of operation and a browser capable of accessing an internal webpage over the Range WiFi. With the electronic target system, competitors are still required to score. Paid score keepers are not permitted. Competitors may be required to assist setting up and taking down targets; failure to do so may lead to disqualification. In the event of a catastrophic failure or malfunction of the electronic target system, the Match Director will reserve the right to either delay the match or to switch to manual targets. All competitors will be required to perform pit duties if such a case arises. If a substitute puller is used, the competitor shall accompany the substitute puller and is responsible for their attendance and performance in the pits. Please use our web site for updates.
